Time and Place

The board meeting of the Appalachian Authors Guild was held on Tuesday, August 11, 2020 at the Virginia Highlands Small Business Incubator from 12 p.m. - 1 p.m., with a workshop following from 1 p.m. - 3 p.m.

President Vicki Fletcher, Ellen Myatt, Addie Davis, Linda Hoagland, JC Schweingrouber, and Dan Swanson attended the board meeting. For the workshop, the above attended as well as Connie Wohlford and her guest, Molly Keller.

Call to Order

President Vicki Fletcher called the meeting to order.

Business

- 1. Welcome and opening of the meeting President Vicki Fletcher
- 2. *Minutes* for the June 30, 2020 AAG board meeting and minutes for the AAG General Membership Meeting held July 14, 2020 were reviewed and approved.
- 3. *Treasurer's Report*. Due to COVID 19, Treasurer Jack Rose could not attend the meeting. Vicki prepared the treasurer's report.

- 4. Pending expenses. President Vicki noted that \$204.66 will be deducted for the cost of new cookbooks and 7 or 8 anthologies ordered. In addition, approximately \$300 will need to be paid in September for the Website. President Vicki also mentioned that due to being unaware the Guild needed to file annually to receive the Tax Exempt status ID, the cost to refile is \$275, which the organization cannot afford at this time. This status helps when purchasing items for Spring Fling and other events.
- 5. Fundraising was a topic raised by Dan Swanson and the possible need for a Fundraising *Committee*. While President Vicki noted that usually funds cover the Guild's annual needed,

this year the budget is tight. JC Schweingrouber said options include Go Fund Me and putting a "Donor Drive" on the Guild's Facebook page.

President Vicki was concerned that too much funding might put the Guild in an unfavorable tax bracket, but JC Schweingrouber said that was only if the organization received funds in excess of \$25,000, based on the information he has for his non-profit. AAG still retains a 501(c)(3) status.

JC Schweingrouber and Dan Swanson agreed to look into the two possible funding outlets.


